Course Description

Why Be Certified

Successfully completing the BCEN's CEN or CNA's ENC(C) Exam is a challenge that has been completed by only a minority of emergency nurses. Successful completion of this exam exhibits to others that the bearer has demonstrated a knowledge base in the specialty of emergency nursing that exceeds his or her peers.

- Describe the CEN or ENC(C) Exam, test plan and the practice requirements to sit for the exam.
- Construct a study plan for the exam based on understanding the blueprint, competencies and domains of practice covered.

- Recall the core components covered in the exam through didactic supplementation and test questions.
